Building on the work already done in Australia and the UK taking the Maternal Mental Health Alliance and 1001Critical Days as a model:

Joining all those organisations currently working towards these goals into a strong coalition to ensure:

• Strong public campaigns to promote understanding of the benefits of a best start to life

- All of Australia is mapped to show where gaps exist so that local area government will work to ensure that their area has great services this has been marvelously successful in the UK
- Support from all levels of government
- Specific, time-limited goals to ensure universal availability of services for women with severe mental illness
- Services for infants are prioritised with a clear understanding of the benefits of:
 - promotion of positive infant mental health,
 - early identification of potential family problems, particularly focusing on maternal mental illness
 - treatment of infant mental health problems as early as possible
- Training in perinatal and infant mental health is available for all those involved in the care of pregnant and postnatal women and their infants thus including midwives, obstetricians, child health nurses, GPs, community mental health workers, and so on

Yes, it's quite a vision. But why not? I think about smoking and how attitudes to that have changed in my lifetime (did I REALLY used to smoke...?)

From where I sit, with the cessation of the National Perinatal Depression Initiative and the constant pressure on health funding, perinatal and infant mental health needs an organised structure probably with a paid secretariat, to ensure that Australia continues on the marvellous trajectory we have started.

World Maternal Mental Health Day

The University of Otago and Capital and Coast District Health Board in Wellington, New Zealand were delighted to host the first New Zealand Maternal and Infant Mental Health Conference on the 4th May 2016, as part of a worldwide focus on maternal mental health issues and celebrating World Maternal Mental Health Day. The event was a huge success bringing together and delivering training to perinatal mental health practitioners and service users. The national conference attracted 160 attendees - medical and mental health clinicians from across the country, as well as mothers, babies and community and primary health providers.

Feedback was very positive with attendees saying they would be able to use the knowledge gained to take back into the community. One said: "I come across mental health and domestic issues all the time in my work in communities. Knowledge from this conference has given me more confidence in my work working alongside mothers and communities". Additional efforts by the team with a movie fundraiser *(The Maiden's Blush)* in conjunction with the conference raised funds for Post Natal Distress Wellington.

Call for Abstracts: Marcé Australasian Chapter conference 2017

Abstract submissions close 3 April 2017

The Organising Committee invites abstract submissions for presentations at the biennial Australasian Marcé Society for Perinatal Mental Health 2017 Conference. All abstracts submissions must be made by completing the online submission form and attaching your abstract as per the layout guidelines.

Authors are invited to submit abstracts for oral and poster presentations. Please indicate the preferred platform on the submission form. The allocation of presentations is at the discretion of the Organising Committee.

There is no limit to the number of abstracts you may submit.

As a commitment to attend and support the Conference, accepted presenters are expected to register and pay for a **full or day registration.** Potential presenters should note that all costs to attend the Conference must be met from their own resources.

Key Dates

3 April
Deadline for abstract submission at 5:00pm AEST.
Mid-June 2017
Authors will be notified by email of the result of their abstract submission.
1 September 2017
Presenter registration deadline.

General Guidelines for Submissions

Abstracts will only be accepted by submitting through the online process. The abstract content must be uploaded into the system in a Microsoft Word .doc or .docx format.

Abstracts must not exceed 300 words.

Layout

Abstracts are to be submitted in the format described below. They must include; Title Authors Affiliation of authors E-mail of corresponding author Presenting author underlined The presenting author must be registered by 1 September 2017.

Formatting

Paper Title: Bold in Title Case, Arial, font size 12

Authors Names: Names should be supplied in the given (first) name first, surname (family) name last format. Bold in Title Case, Arial, font size 10, underline presenting author(s)

Author's Affiliations: All affiliations should contain institution, city and country and be in sentence case. Please use superscripts to match each author with his/her affiliation) e.g. Cris Stagg1 and Ian Parry2

Email: e-mail of corresponding author

Descriptive text: Sentence case, Arial font size 10. Single spacing (1.0) * Note that characters and symbols must be inserted into the document using the INSERT SYMBOL function, not by changing the font, and please do not use document styles

Do NOT include references

Overall word count, excluding the scientific title, authors and affiliations must not exceed 300 words

Abbreviations: full text on first mention followed by the abbreviation of first parenthesis

Presentation Options

You will requested to nominate one of four presentation platforms at the time of submission.

Paper (30 minutes including 5 minutes for questions/discussion)

Symposium (90 minutes including 3-4 related papers – you must provide an abstract for each paper and indicate on the online submission form, the preferred sequence the papers are to be presented

Poster

Workshop (90-minute session)

Statement on Ethical Compliance

The Marcé Society is committed to ethically-responsible reporting of research and clinical work. In order to ensure this, all presenters are asked to indicate compliance with ethical standards on the online submission form.

1. Reports on research using human participants with approval from an Institutional Human Research Ethics Committee

2. Reports on clinical work using video or audio recording of patients/clients with their permission for use at conferences/meetings

3. Reports on clinical work using video or audio recording of patients/clients with their permission for use with an audience of health professionals only

4. Reports on work with quality improvement project approval

5. Does not report on research using human participants nor on clinical work using video or audio recording of patients/clients

Publication

Abstracts presented at The Australasian Marcé Society 2017 Conference will be published in the Conference Proceedings.
